Acceptable Oil Tanks Accessories Installed on Granby Industries Residential ULC Listed Oil Tanks.

To all our wholesale customers, oil heat technicians and installers, heating oil companies, local and provincial authorities having jurisdiction and industry associates.

Environmental safety along with complete installation conformity remains a top priority for Granby Industries. With this in mind, due to increasing concerns around the possible use of some non ULC listed and/or non CAN/CSA B139 compliant oil tank accessories installed on and/or used in combination with Granby Industries residential ULC-S602 and ULC-S670 listed oil tanks, Granby Industries would like to inform everyone of the following effective January 1, 2021.

Starting January 1, 2021, new installations of Granby Industries residential ULC-S602 and ULC-S670 listed oil tanks will require that overfill protection vent alarms (whistles), oil-level gauges and oil deaerators installed on and/or used in combination with the above mentioned Granby oil tanks be only those that are Granby branded and/or distributed by Granby. The use of any other brands of overfill protection vent alarms (whistles), oil level gauges and oil deaerators not manufactured or distributed by Granby Industries installed on and/or used in combination with Granby Industries residential ULC-S602 and ULC-S670 listed oil tanks will be deemed inacceptable for use by Granby Industries. Under Granby oil tank Limited Warranty documents, the 'improper matching or application of the tank or the tank's components' will void Granby tanks limited warranties. This will become effective also for the replacement and/or installation of above-mentioned oil tank accessories on existing residential Granby/Vilco/Superior branded, ULC listed oil tanks starting January 1, 2021.

Granby Industries residential ULC-S602 and ULC-S670 listed oil tank installation documents will reflect this announcement as of January 1, 2021.

Granby Industries offers a complete and competitive range of ULC listed and CAN/CSA B139 compliant overfill protection alarms (whistles), oil level gauges and oil deaerators as well as many other oil tank accessories, all of which are available through Granby's wholesaler distribution network across Canada.
